This grant is aimed to support communities that provide strong evidence of their dedication and readiness to collaborate among community organizations. Priority consideration will be granted to Milestone municipalities.

**The application deadline is Oct. 31st, 2024.**  
**Successful applicants will be notified by Dec. 15th, 2024.**  
**An interim/final grant report will be due by March 1st, 2025.**
