Manitoba Security Rebate Program

The Manitoba Security Rebate Program provides financial assistance to homeowners, tenants and small businesses for the purchase and installation of security equipment. The program aims to reduce crime rates and promote safer neighbourhoods throughout the province. Through the program, eligible Manitobans can receive up to \$300 for the purchase and installation of qualifying security equipment.

- **Eligible Security Equipment:** The rebate covers preventative security products, including but not limited to security cameras, alarm systems, motion detectors, reinforced doors or windows, anti-graffiti film and paint, security gates, pull-down protection shutters and permanent security fencing.
- **Eligibility Criteria:** The program is open to all Manitoba homeowners, tenants and small businesses that purchase and install qualifying security equipment after September 1, 2023, on a first-come, first-served basis. The program does not cover expenses associated with vandalism, property damage repairs or monthly subscription fees.
- **Required Documentation:** Applicants must provide proof of purchase, installation details and various identifying documents to confirm eligibility for the program. This includes proof of identity of the applicant (e.g. valid Manitoba driver's licence, Manitoba Identification Card, Canadian passport or Indigenous status card).
